## **ERC** to Release Report Documenting Discrimination Against Voucher Holders in the District

Mayor Gray, DOJ Assistant Attorney General Perez to participate in 10<sup>th</sup> Annual Fair Housing Symposium following press conference

WASHINGTON, D.C., April 25, 2011 –This Thursday, April 28<sup>th</sup>, the Equal Rights Center (ERC)—a national civil rights non-profit organization—will be joined by Gustavo Velasquez, Director of the D.C. Office of Human Rights to release a new report documenting rates of discrimination against voucher holders in D.C. based on an expansive investigation conducted by the ERC.

Under the D.C. Human Rights Act, District landlords and property managers are prohibited from discriminating against an individual because he or she wants to pay rent with various types of funds, including government subsidies such as Housing Choice Vouchers. The report, *Still in Search of Decent Housing*, was issued as a follow up to a 2005 ERC report that documented a staggering 61% rate of discrimination against voucher holders in the District.

Following the press conference, in recognition of National Fair Housing Month, the D.C.'s 10<sup>th</sup> Annual Fair Housing Symposium will be held from 10:00 a.m. to 4:00 p.m. **D.C. Mayor Vincent Gray** will deliver opening remarks and **Tom Perez**, Assistant Attorney General for the Civil Rights Division of the United States Department of Justice, will deliver the keynote address.
