THROUGHOUT THE COURSE OF 2024, THE ERC CONDUCTED A TOTAL OF 868 CIVIL RIGHTS TESTS, RESPONDED TO 683 INDIVIDUALS REPORTING DISCRIMINATION, FILED 12 ADMINISTRATIVE COMPLAINTS WITH LOCAL CIVIL RIGHTS ENFORCEMENT AGENCIES WHICH YIELDED NEARLY \$90,000 IN MONETARY RELIEF, AND SUBMITTED 32 REASONABLE ACCOMMODATION AND MODIFICATION REQUESTS ON BEHALF OF PEOPLE WITH DISABILITIES. THE ERC ALSO TRAINED HOUSING PROFESSIONALS AND MEMBERS OF THE COMMUNITY IN FAIR HOUSING AND ACCESSIBILITY REQUIREMENTS. IT ROLLED OUT AN UPDATED STRUCTURE FOR ITS MULTI-FAMILY HOUSING RESOURCE PROGRAM, DESIGNED TO ASSIST AND GUIDE THE PRIVATE SECTOR IN MAINTAINING COMPLIANCE WITH A VARIETY OF CIVIL RIGHTS LAWS BY PROVIDING TRAINING, COMPLIANCE TESTING, AND BEST PRACTICES BASED TECHNICAL ASSISTANCE TO CORPORATE CLIENTS RANGING FROM SMALL LANDLORDS
