Program Overview

The Multifamily Housing Resource Program (MHRP) is a trailblazing membership program for housing industry leaders dedicated to assisting multifamily housing developers to comply with federal and other accessibility requirements, and to increasing the number of accessible apartments and condominiums in the United States.

MHRP Philosophy:

- Offering accessible housing expands the potential customer base to include the growing market of home renters and buyers with disabilities.
- Accessible design is attractive design, tending to create more open kitchen, bathroom, and unit designs that appeal to all residents.
- Providing accessible and adaptable units will allow residents to age in place, as the general population grows older.
- The cost of addressing accessibility on a retrofit basis far exceeds the cost of ensuring compliant design and construction at the earliest stages of every multifamily housing project.

Since its founding in 2008, MHRP has...

Grown to 17 members.

Provided housing, by way of our members, for many of the nation's 57 million individuals with disabilities, along with the rising population of individuals who need equitable resources & the opportunity to live where they choose. Included over 600,000 apartments and condominiums across the country.

Included industry leaders in the areas of multifamily housing development, design, construction & property management.

Program Highlights

Service & Assistance Animals

This year, the ERC partnered with the Humane Rescue Alliance (HRA) and the American Society for the Prevention of Cruelty to Animals (ASPCA) to develop and conduct educational trainings surrounding the use of assistance and service animals. The trainings provided information about individuals' rights regarding service and assistance animals in public accommodations and housing, and the appropriate use of such animals.





Multifamily Executive Conference

This September, ERC Executive Director Melvina Ford participated in the national Multifamily Executive Conference in Las Vegas, NV. Melvina facilitated a panel discussion with Christina Steeg, Senior VP of Marketing and Training at Simpson Housing, and Caroline Elmendorf, Compliance Officer at MHRP member, Bozzuto, about the use of criminal records screening policies in housing. She provided information about the legal landscape, recent HUD guidance, and best practices around this issue. Caroline discussed Bozzuto's criminal records screening policies and best practices, and outlined how housing developers should approach compliance and advocacy. In addition to this panel, Melvina conducted a video interview about the ERC's Fair Housing App that will be featured on the Multifamily Executive website in the coming months.

Equal Rights Learning Center (ERLC)

This year, the ERC fully launched its new online learning center through the Litmos platform. The new Equal Rights Learning Center site has streamlined MHRP member trainings and allowed for more efficient course completion and data reporting.



Instruction and Training:

- Access to courses through the ERC's online system (ERLC) significantly expands the reach of accessibility and fair housing information by enabling members to share this learning opportunity with employees and stakeholders remotely.
- The ERC provides in-person trainings about important issues, strategies, and trends relevant to accessibility, inclusion, and equity in the housing arena. These courses are customized to effectively reach tiered staffing structures and address individual members' organizational needs.

Testing and Surveying:

- Civil rights testing is an investigative tool used to gather evidence, usually in order to compare conduct or design and construction to legal requirements or a policy. It involves one or more people covertly engaging in an interaction or surveying a physical space.
- The ERC sruveys and assesses properties to ensure that FHA & ADA requirements are being followed. Additionally, surveys provide ideas and best practices for complying with the law.

Sharing and Empowering:

- The staff reviews members' policies, procedures, and customer related documents to ensure that language and information is reflective of fair housing & accessibility laws and best practices.
- The ERC also develops and provides manuals and materials related to various topics on accessibility and fair housing.
